- These Terms apply to all members of the QPR 'W12 Club' for the 2008/2009 Championship Season.
- The fee for membership of the W12 Club is £3,000 plus VAT payable to QPR by 1 August 2008.
- Payment of the above fee entitles the Member to the following (the 'Package'):
  - one seat at the Loftus Road Stadium in the area designated for W12 Club members at all first team Championship matches and any testimonials and first team friendly matches played during the Season (each, a 'Match');
  - the other facilities and benefits provided to members of the W12 Club as set out in the Package Details section of the Application Form provided to the Member (the 'Application Form'); and
  - upon written request by the Member and subject to availability, one car parking space for each Match provided that parking shall be at the Member's risk and QPR shall not be liable for any loss or damage to any vehicle or personal items.
- QPR reserves the right to alter the terms of the Package at any time prior to the first Match of the Season by written notice to the Member.
- If QPR is unable to provide the Package or any part of it, QPR shall, subject to availability, provide the Member with an alternative that is equivalent, as nearly as practicable, to the Package. If no such alternative is available, QPR shall reimburse the Member an amount pro rata to the fee for each missed Match (unless the Package was unavailable through the fault of the Member).
- The Member shall conduct himself in a good and orderly manner whilst at the Stadium. The Member shall comply with all rules and regulations and any requests, directions or instructions communicated to him/her by any representative of QPR. QPR may require the Member to leave the Stadium for failure to comply with this paragraph.
- All food, drink, catering and merchandise will be provided by or must be exclusively purchased from QPR or its appointed contractor and, where the same is not included in the Package, at its/their price list.
- Any payments in addition to the fee shall be made in full to QPR within 7 days of the date of the relevant invoice. All payments will be subject to the addition of VAT if applicable. Without prejudice to any other right or remedy, QPR may charge interest on any overdue amounts at the rate of 2% per annum above the base rate of Lloyds Bank plc from time to time on a daily basis from the due date until the date of actual payment of the overdue amount, whether before or after judgment. The Member shall pay such interest on demand.

- The Member shall not use within the Stadium any equipment that is capable of recording or transmitting (by digital or other means) any audio, visual or audio-visual material or any information or data in relation to a Match or the Stadium. Copyright in any unauthorised recording or transmission is assigned (by way of present assignment of future copyright pursuant to section 91 of the Copyright, Designs and Patents Act 1988) to QPR. The Member shall comply with any direction from QPR to destroy or deliver up any unauthorised recording or transmission.
- THE ATTENTION OF THE MEMBER IS DRAWN SPECIFICALLY TO THE FOLLOWING PARAGRAPHS
  - QPR's liability in contract, tort or otherwise arising in relation to the Package shall be limited to the amount of the fee. Nothing in these Terms shall exclude or limit any liability of QPR for death or bodily injury caused by the negligence of QPR or its directors, officers, employees or representatives.
  - In consideration of the provision of the Package, the Member shall indemnify QPR against all liabilities, costs, expenses, damages and losses suffered or incurred by QPR arising out of or in connection with any breach of these Terms by the Member.
- Without prejudice to any other right or remedy, QPR may suspend or terminate the Member's membership of the W12 Club without liability to the Member by giving written notice to the Member if the Member commits a breach of any provision of these Terms.
- The Member shall not assign, transfer, charge or otherwise deal with the benefit of these Terms or any of its rights or obligations hereunder.
- No failure or delay by QPR to exercise any right or remedy provided under these Terms or by law shall constitute a waiver of that or any other right or remedy, nor shall it preclude or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall preclude or restrict the further exercise of that or any other right or remedy.
- The rights and remedies provided to QPR under these Terms are in addition to, and not exclusive of, any rights or remedies provided by law.
- These Terms and the Application Form constitute the whole agreement between the parties and supersede all previous agreements, understandings, arrangements or representations between the parties relating to their subject matter.
- No person other than QPR and the Member shall have any rights under or in connection with these Terms.
- These Terms shall be governed and construed in accordance with the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
